# **Brief note of biographies**

### Mary taylor:

Dr Mary Taylor is recognised in UK as a housing pracademic. Her expertise is mainly in social housing, especially in the not-for-profit sector providing affordable housing, which plays an important role in the Scottish system. She has held diverse roles including organisational and professional leadership, research and teaching on housing at the University of Stirling, and conference contributor at home and abroad. Although retired since 2017, she remains committed to affordable housing, not just in Scotland and UK. She supports advice to the United Nations Economic Commission for Europe (<u>UNECE</u>) on housing.

#### Conor O'Toole.

Dr Conor O'Toole is an Associate Research Professor at the Economic and Social Research Institute and a member of the UNECE Real Estate Markets Advisory Group. He previously held the position of Manager – Real-Financial Linkages Team and Senior Economist at the Financial Stability Division of the Central Bank of Ireland. At the Central Bank of Ireland, Conor worked extensively on macroprudential policy issues with specific focus on the mortgage market. He also worked on broader issues regarding the surveillance of household and corporate financing vulnerabilities. Conor was a member of the European Central Bank's Macroprudential Policy Group Taskforce on Operationalising Macroprudential Research. His research has been published extensively in peer-reviewed journals including the Journal of Money, Credit and Banking, Review of Finance, Journal of Financial Stability, Journal of Housing Economics, Real Estate Economics, Journal of Real Estate Economics and Finance, Journal of Banking and Finance, and the Journal of Corporate Finance. His research interests cover housing, banking and SME financing issues.

#### Raúl Garcia-Rodriguez,:

Raul leads the Sustainability practice in Risk Advisory at Deloitte CZ & SK. His experience includes more than 25 years of international appointments in Public Institutions & Private Corporations. Specialised in real assets' investments, Raul managed an investment portfolio of industrial and commercial real estate with developments in renewable energy and agriculture. With strong command in urban development, project finance & technology adoption to be applied to real assets' business, he is also involved in projects related to smart cities. #### Nikolaos Triatafyllopoulos:

Nikolaos Triantafyllopoulos is Assistant Professor on Urban Planning and Real Estate at the University of Thessaly in Greece. His main research interests include urban planning and land policies, real estate development, public-private partnerships, tourism and housing. He has participated in a number of European and national research projects, and has published papers in international and Greek scientific journals and collective volumes. He is a member of the Working Group on Real Estate Markets of the United Nations – Economic Commission for Europe. He also serves as a consultant to Ministries, national and international private enterprises and public authorities in large urban planning and real estate projects.

#### Paloma Taltavull de La Paz

Dr Paloma Taltavull de La Paz is full Professor on Applied Economics Department at the University of Alicante, Spain and she has been visiting scholar at University of California at Berkeley, Georgia State University and Florida International University and Massachusetts Institute of Technology (MIT). Her research focus is in Housing Markets, Real Estate Markets and Macroeconomics and energy and sustainable housing markets. She has written more than 40 book chapters and books, around 80 academic articles in Spanish and International journals since 1996 (Journal of European Real Estate Research, International Journal of Housing Market and Analysis, Urban Studies, Housing Studies, among others) and has participated in more than 40 research projects in housing and urban economics refereed to Spanish and European markets since 1992 and two H2020 projects related to energy issues and housing/real estate markets. Professor Taltavull belongs to different international academic Societies committees, she is the Chair of REM (Real Estate Advidsory Group), she was Outstanding Academic Member of the Housing Rent Market Observatory at the Spanish Ministry of Housing (2006-2009), and she led the launch of the Biblioteca Virtual Miguel de Cervantes (Virtual Library 'Miguel de Cervantes'), the first virtual library in Europe and in Spanish language, in 1999.

Ms Beunza is the former General Secretary of Housing in the Spanish Government.
